I called the Division of Corporations today and they instructed me to obtain the enclosed form off of the internet and get it mailed immediately.

Because this UBR reflects a change of address, I am assuming that represents a 'Amended UBR', and as such I am including the additional \$61.25 called for by an amended UBR. Also I included an additional \$8.75 to have a certificate of status provided. Thus explaining the total check amount for \$220. (There is no place on the form that allows me to show such an itemization.)
