ARTICLE I - NAME

The name of this Corporation is PROFESSIONAL CREDIT & FINANCIAL SERVICES, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on July 16, 2001.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.


