The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

<u>FIRST</u>: The name of the corporation (hereinafter called the "corporation") is DARREN R. GOLDSTEIN P.A. The mailing address and principal place of business of the corporation is 287 E. Indiantown Road, Suite B-1, Jupiter, FL 33477.

SECOND: The duration of the corporation shall be
