# ARTICLES OF INCORPORATION OF

## PROFESSIONAL CARE PROVIDERS OF SOUTH FLORIDA, INC.

#### ARTICLE I - NAME

The name of the corporation is PROFESSIONAL CARE PROVIDERS OF SOUTH FLORIDA, INC. (hereinafter called the "Corporation").

#### ARTICLE II - PURPOSE

A. - C. To purchase the corporate assets of any other corporation and engage in the same or other character or business.
- D. To guarantee, endorse, purchase, hold, sell, transfer mortgage, pledge or otherwise acquire or dispose of the capital stock of, or any bonds, securities or any other evidence of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
- E. To manufacture, purchase, or otherwise acquire, own, mortgage, pledge sell, assign, and transfer or otherwise dispose of, to invest, trade, deal in and deal with, goods, wares and merchandise and real and personal property of every class and description.

## ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 100 shares of Common Stock, per value \$.001 per share.

#### ARTICLE IV - INITIAL REGISTERED AGENT

## ARTICLE IX-INDEMNIFICATION OF OFFICERS AND DIRECTORS.

The foregoing right of indemnification shall be in addition to but not exclusive of all other rights to which such officer or director may be entitled.
