Article I - Name

The name of this corporation is T.K.D., INC. The mailing address/principal office of the corporation is:1309 N. Wembley Circle, Port Orange, Florida 32128.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purposes

Article V - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

Article VI - Initial Registered Office and Agent
