2. The following amendment to the Articles of Incorporation was adopted by the Board of

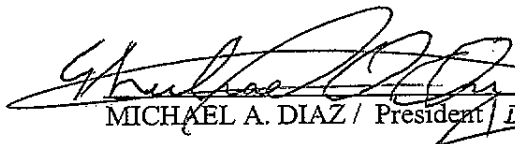
Directors of the corporation on June 3, 2002, in the manner prescribed by the Florida business Corporation Act:
