The undersigned, for the purpose of creating a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

CORPORATE NAME AND PRINCIPAL OFFICE

The name of the corporation is BULLDOG EXPRESS SHUTLLE, INC. and its principal office and mailing address is 271 Ewing Court, Fort Walton Beach, FL 32548.

ARTICLE TWO

NATURE OF BUSINESS


