ARTICLES OF INCORPORATION OF TOWERON, INC.

I, the undersigned, desiring to form a corporation for the purposes hereinafter stated, under and pursuant to Chapter 687 of the Florida Statutes, do hereby declare as follows:

ARTICLE I

The name of the corporation shall be:

ARTICLE II BUSINESS AND PONERS
