
ARTICLE X



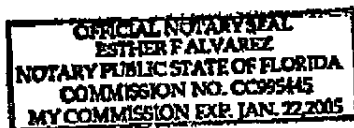
