**ARTICLE I**  
**Name and Duration**

The name of the Corporation shall be J. JIMENEZ & ASSOCIATES, P.A. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

This corporation shall have an effective date of JULY 2, 2001

**ARTICLE II**  
**Principal Office**

The address of the principal office of the Corporation is 9753 S. Orange Blossom Trail, Suite 101, Orlando, Florida 32837.

**ARTICLE III**  
**Registered Office and Agent**

The address of the registered office in the State of Florida is 9753 S. Orange Blossom Trail, Suite 101, Orlando, Florida 32837.

**ARTICLE IV**  
**Corporate Purposes, Powers and Rights**

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in the practice of law, and any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

2. If any vacancy occurs in the Board of Directors during a term, the remaining directors, by affirmative vote of a majority thereof, may elect a director to fill the vacancy until the next annual meeting of shareholders.

**ARTICLE IX**  
**Bylaws**

The power to adopt, amend or repeal bylaws for the management of this Corporation shall be vested in the Board of Directors or the shareholders.

**ARTICLE X**  
**Indemnification**


The Corporation shall indemnify any incorporator, officer or director, or any former incorporator, officer or director, to the full extent permitted by law.

**ARTICLE XI**  
**Transfer of Shares**

If, from time to time, a shareholders' agreement among all of the shareholders of the Corporation is in effect regarding the Subchapter S status of the Corporation pursuant to the Internal Revenue Code of the United States in effect from time to time, then transfers of the Corporation's Common Stock made not in accordance with such agreement, whether by operation of law or otherwise, are null and void ab initio.
