TO THE
ARTICLES OF INCORPORATION
NU-WAY RECYCLING CORP.
(A Florida For Profit Corporation)

Pursuant to the provisions of section 607.1006, Florida Statutes and the Bylaws of the corporation, this Florida Profit Corporation adopts the following amendments to its Articles of Incorporation:

ARTICLE I:

The Articles of Incorporation of the Corporation are hereby amended by deleting Article I thereof in its entirety and substituting the following in its place:

"ARTICLE I

The name of the corporation is J&A Holdings Group, Inc."
