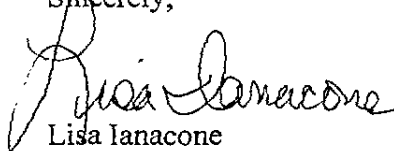

ARTICLE I: The name of the Incorporation shall be amended to STILL BREAK, INC.

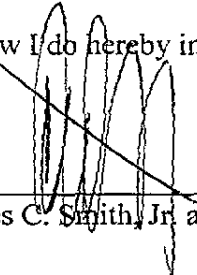
FIFTH: Article IV of the Articles of Incorporation previously provided as follows;

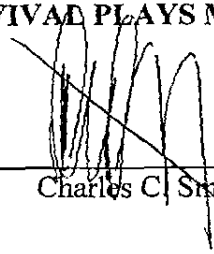
EIGHTH: The amendments were adopted on November 5, 2005.
