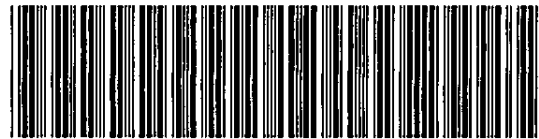



ARTICLE I: "The name of the Corporation is: STILL BREAK, INC.


