Name**

The name of the Corporation is **La Princesse Beauty Supply, Inc.**, hereinafter referred to as the "Corporation".

**II.
Purposes**

The purpose of the Corporation is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

**III.
Principal Office and Registered Agent**

The duration of the Corporation shall be perpetual.

Initial Business**

The total number of shares the Corporation shall have authority to issue is **100**, each share to have a par value of **\$1.00**.
