ARTICLE I

The name and address of the incorporator (s) (is) (are) ORLANDO M & IBIS C MESA 14624 SW 174 TERR MIAMI, FL 33177.

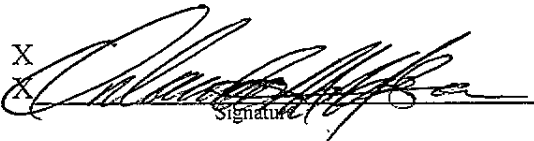
ARTICLE IX
