**BY THESE ARTICLES OF INCORPORATION** the incorporator forms a corporation for profit under Florida law.

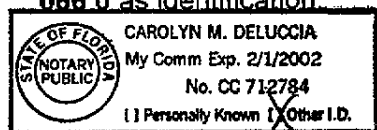
1. **NAME.** The name of the corporation is **ELITE ELECTRICAL CONTRACTORS, INC.**


