ARTICLE I - NAME

The name of the corporation shall be *CANAVERAL JETS, Inc.*

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the filing of these articles with the Secretary of State of the State of Florida.

ARTICLE III - PRINCIPAL OFFICE
