ARTICLES OF INCORPORATION
of
Indian River Pathology, P.A.

The undersigned natural person, who is licensed or otherwise legally authorized to practice the profession of medicine in the State of Florida, hereby associates himself in accordance with the Florida Professional Services Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I: NAME

The name of the corporation is Indian River Pathology, P.A.

ARTICLE II: DURATION

This Corporation shall exist perpetually.

ARTICLE III: PURPOSE
