ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these articles of incorporation, being duly licensed to pure law under the laws of the state of Florida, adopts these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. ARTICLE IX. RESTRAINT ON ALIENATION OF SHARES
