**ARTICLES OF INCORPORATION
OF
GH TRUCKS AND EQUIPMENT, INC.**

The undersigned, acting as incorporator of GH TRUCKS AND EQUIPMENT, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is GH TRUCKS AND EQUIPMENT, INC. (the "Corporation").

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE


ARTICLE VIII. BYLAWS


