## ARTICLE I

### CORPORATION NAME

The name of the corporation is Tiger Training Academy, Inc.

## ARTICLE II

### PRINCIPAL PLACE OF BUSINESS

The principal place of business, offices, and mailing address of the corporation is 806 Carlton Street, Clearwater, Florida 33755.

## ARTICLE III

### PURPOSE

The purpose for which this corporation was created is to operate a security training school as defined by Chapter 493 of the Florida Statutes.
