# ARTICLES OF INCORPORATION

OF

#### ARTICLE I - NAME

The name of the corporation is Kevin Santos A Nu Lawn Service, Inc., 331 Araphoe Lane NE, Palm Bay, Florida 32907 (Principal Office of Registered Agent).

#### **ARTICLE II - DURATION**
