#### AMENDED AND RESTATED ARTICLES OF INCORPORATION OF TOURPASS, INC.

Pursuant to the requirements of Section 607.1007 of the Florida Business Corporation Act, the undersigned does hereby make, swear to, adopt and file these Amended and Restated Articles of Incorporation of TOURPASS, INC. (the "Company"), which Company was incorporated in the State of Florida on July 25, 2001, charter number P01000073129.

1. The sole shareholder of the Company has unanimously voted to adopt the Amended and Restated Articles of Incorporation. Therefore, Articles I through XIV of the Company's Articles of Incorporation are deleted in their entirety and are amended and restated as follows:

#### ARTICLE I

Name

The name of the Company is TOURPASS, INC.

#### **ARTICLE II**

#### Principal Office

The address of the principal office of the Company is 800 Corporate Drive, Suite 408, Fort Lauderdale, Florida 33334.

#### ARTICLE III

#### Capital Stock

The Company is authorized to issue 10,000,000 shares of common stock, par value \$.01 per share and 1,000,000 shares of preferred stock, par value \$.01 per share.

The preferred stock may be issued from time to time, in one or more classes or series, the shares of each class or series to have such preferences, limitations and relative rights as are stated in the resolution or resolutions providing for the issuance of such class or series adopted by the Board of Directors.



#### ARTICLE IV

#### Registered Agent and Office

The registered agent of the Company shall be Doménico D'Alfonso and the registered office address of the Company shall be 800 Corporate Drive, Suite 408, Fort Lauderdale, Florida 33334.

#### ARTICLE V

#### Board of Directors

The number of members of the Board of Directors shall not be less than one (1), with the exact number of directors to be specified from time to time in the manner provided in the Company's bylaws.

#### ARTICLE VI

#### Corporate Purposes and Powers

The purpose of the Company is to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida. The Company shall have all of the powers and rights conferred upon corporations under the laws of the State of Florida to carry out such purpose.

#### ARTICLE VII

#### **Bylaws**

The power to adopt, amend or repeal the Company's bylaws shall be vested in the Board of Directors or the shareholders, but the Board of Directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the Board of Directors.

#### ARTICLE VIII

#### <u>Amendment</u>

These Articles of Incorporation may be amended, altered, changed or repealed by the Company's shareholders in accordance with Florida law.

#### ARTICLE IX

#### <u>Indemnification</u>

The Company shall indemnify any incorporator, officer or director, or any former incorporator, officer or director, to the fullest extent permitted by law.

The foregoing Amended and Restated Articles of Incorporation of Tourpass, Inc. was unanimously adopted by the sole director of the Board of Directors and the sole shareholder of the Company on the 24th day of April, 2003.
