I am writing to request a waiver of the \$400.00 late fee which the Division of Corporations may require for the late filing of a UBR for The Closing Center, Inc.. The Closing Center, Inc. had previously filed its UBR prior to May 1, 2002 and had forwarded the \$150.00 filing fee which the Division has received. Due to an omission regarding the FEI number on the UBR, the Report was returned to the Closing Center, Inc. for correction and re-submittal. The correction was made, and the UBR was resubmitted prior to May 1, 2002.
