

The undersigned person[s], acting as incorporator[s] of a corporation organized under the laws of the state of Florida hereby adopt[s] the following Articles of Incorporation:

ARTICLE 1
CORPORATE NAME


**ARTICLE VII

Any director or officer who is involved in litigation or other proceeding by reason of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.


