The undersigned, for the purpose of forming a corporation under Chapter 617, Florida Statutes, does hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be:

The corporation shall commence to be in existence upon the filing of these Articles of Incorporation by the Department of State of the State of Florida and the term of existence shall be perpetual.
