
ARTICLE XI - AMENDMENT



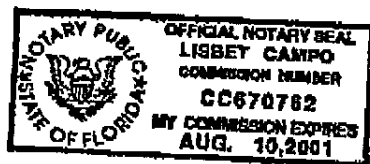
