#### ARTICLES OF INCORPORATION

OF

The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

# ARTICLE I. Name of Corporation

# ARTICLE II. Nature of Business

The general nature of the business and activities to be transacted and carried on by this Corporation are as follows:

- (3) The contract or transaction is fair and reasonable as to the Corporation at the time it is authorized by the Board of Directors, a committee thereof, or the shareholders.




