ARTICLE I - NAME

The name of this Corporation is: **GATOR CLASSIC DANCESPORT, INC.**

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.



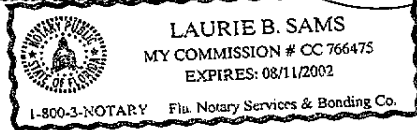
