The Uniform Business Report for 2002 for Palm Beach Anesthesia Partners, Inc. (the "Corporation") was timely filed with the Division of Corporations. The Report was rejected and returned to the Corporation on June 2, 2002 and again on June 20, 2002. The Division of Corporations requested the Report be corrected and returned by July 20, 2002. The Report was corrected and returned to the Division of Corporations prior to the July 20, 2002 deadline.
