

ARTICLES OF INCORPORATION OF MONEY MARKET MORTGAGE, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned being a natural person, hereby acts as an incorporator in adopting and filing the following, articles of incorporation for the purpose of organizing a business corporation.
