**ARTICLE I - NAME**

The name of this Corporation shall be: HORIZON ADVERTISING & MEDIA, INC.

**ARTICLE II - COMMENCEMENT & DURATION**

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.

**ARTICLE III - PURPOSE**

Such offer shall be in writing, signed by the shareholder, sent by registered or certified mail to this corporation at its registered office address, and open for acceptance by this corporation for a period of fifteen days from the date of mailing.
