We, the Undersigned hereby associate ourselves together for the purpose of becoming a corporation under the laws of the **STATE OF FLORIDA** providing for the formation, liability, rights, privileges and immunities of corporation for profit.

ARTICLE I, NAME

The name of the corporation shall be:

PK1 ENTERPRISES, Inc

ARTICLE II, NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE III, CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one hundred (100) shares of common stock, with value of one dollar (\$1.00) per share.

ARTICLE IV, INITIAL CAPITAL

ARTICLE XI, REGISTERED AGENT AND REGISTERED OFFICE




