ARTICLE I. CORPORATE NAME

The name of this Corporation is: BROABE ENTERPRISES, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS

These Articles of Incorporation shall be effective August 1, 2001, as provided by Florida Statute 607.0123.

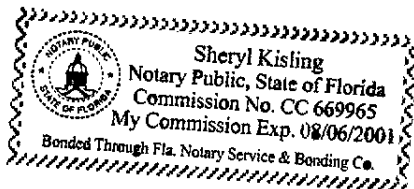
