ARTICLES OF INCORPORATION OF FIRST TRUST AUTOMOTIVE WARRANTY SERVICES, INC.

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

I. Name

The name of the Corporation is First Trust Automotive Warranty Services, Inc.

II. Term of Existence

The date when corporate existence will commence is July 27, 2001 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

III. <u>Principal Office</u>

The principal office and mailing address of the Corporation is 400 North Tampa Street, Suite 120, Tampa, Florida 33602.

IV. Capital Stock

The Corporation is authorized to issue 7,500 shares of \$1.00 par value common stock, which will be designated Common Stock.

V. <u>Initial Registered Office and Agent</u>
