# *Articles of Incorporation of FLORIDA Sandhill Associates, Inc.*

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

## ARTICLE I

FLORIDA

The name of the Corporation ("Corporation") is SANDHILL ASSOCIATES, INC.

## ARTICLE II

The existence of the Corporation shall begin on the date of execution of these Articles.

## ARTICLE III

The street address of the principal office of the Corporation is 1261 Woodville Highway, Crawfordville, Florida 32327.

## ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 300, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

## ARTICLE V

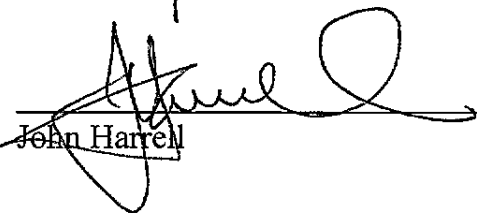
