ARTICLES OF INCORPORATION
OF
FRANCISCO J. RAFOLS, M.D., P.A.

I, the undersigned subscriber of these Articles of Incorporation, a person competent to contract, hereby forms a Professional Association under Chapter 621 of the laws of the State of Florida and adopt the following Articles of Incorporation:

ARTICLE I
CORPORATE NAME

The name of the Corporation is: **FRANCISCO J. RAFOLS, M.D., P.A.**

ARTICLE II
TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE III
NATURE OF BUSINESS

The purpose of the Corporation is : To engage in every aspect of the business of rendering the same professional services to the public that a Physician duly licensed under the laws of the State of Florida, is authorized to render. This Corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other State, Country, Territory, or Nation.

ARTICLE IV
CAPITAL STOCK

The maximum number of authorized shares of this Corporation is: One Hundred (100) shares of common stock having a par value of One Dollar (\$1.00) per share.

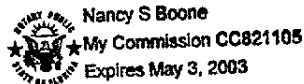
