

Name: The name of this corporation is ABC PROSTHETICS & ORTHOTICS OF CLERMONT, INC. The address of the principal office of this corporation shall be 695 Douglas Avenue, Altamonte Springs, FL 32714.

ARTICLE II

<u>Duration</u>: This corporation shall have perpetual existence.

ARTICLE III
