Name. The name of the corporation shall be: ONSITE FOTOS, INC.

ARTICLE II

Duration and Effective Date. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgement of these articles.

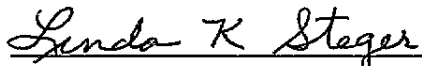
