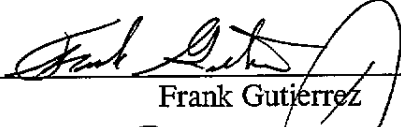
ARTICLE SEVEN - PURPOSE

electronic parts sales, repairs, and installations, provided to businesses and the general public.

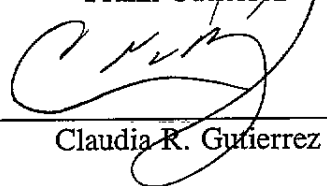
ARTICLE EIGHT - POWERS OF THE DIRECTORS
