ARTICLES OF INCORPORATION OF FIT AMERICA, RESEARCH, INC.

BYRON DAVIS, and DEBI DAVIS, natural persons competent to contract hereby make, subscribe, acknowledge and file in the office of the Secretary of State of the State of Florida for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

ARTICLE I

The name of this corporation shall be as stated above as FIT AMERICA, RESEARCH, INC.

ARTICLE II GENERAL NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the Untied States of America and the State of Florida.

ARTICLE III CAPITAL STOCK
