ARTICLE I NAME: The name of corporation shall be Richard Cunningham Enterprises, Inc.

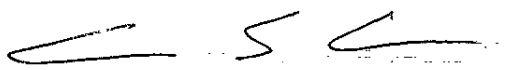

ARTICLE VI INITIAL DIRECTOR: The sole initial director of the corporation is Richard A. Cunningham.

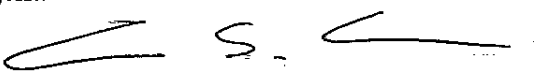
