ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SURETY TITLE SERVICES OF FLORIDA, INC.

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: ARTICLE II - DURATION - is hereby amended to read:

"This Corporation shall have perpetual existence, commencing no later than as of the date of acceptance and filing of these Articles by the Secretary of the State of Florida, and shall exist upon the date of the execution of these Articles if permitted by law. The Address of the principal Corporate Office shall be 28784 U.S. 19 North, Clearwater, FL 33761.

SECOND: ARTICLE III - CAPITAL STOCK - is hereby amended to read:
