

The name of this corporation is LocSat Corporation.

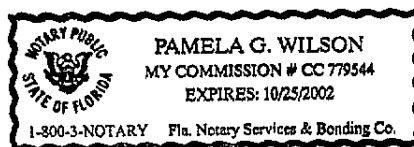
