ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is SUPPORT OUTPOST, INC., and the principal address is 14866 Feather Cove Road, Clearwater, FL 33762.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is 14866 Feather Cove Road, Clearwater, FL 33762. The name of its registered agent at such address is Denis Thellab.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.
