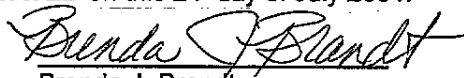
BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

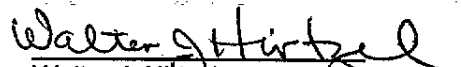
1. NAME. The name of the corporation is **DBT GROUP OF FLORIDA, INC.**

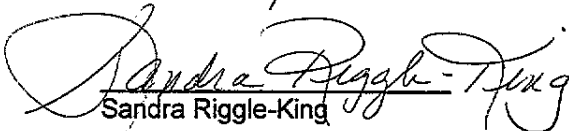

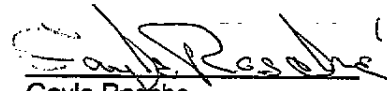
- 2. TERM.** This corporation shall exist perpetually.

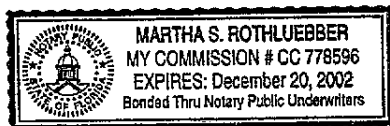

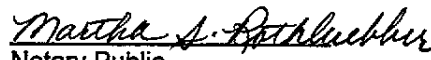
