

ARTICLES OF INCORPORATION OF BDAJD, INC.

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is BDAJD, INC. and its principal place of business shall be located at 1380 Gulf Boulevard, Unit #203, Clearwater, Florida 33767.

ARTICLE II - DURATION
