ARTICLES OF INCORPORATION

OF

THE McCLURE GROUP, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

<u>ARTICLE I - NAME</u>

The name of this corporation is THE McCLURE GROUP, INC.

ARTICLE II - PURPOSE
