ARTICLES OF INCORPORATION

The undersigned Incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation (the "Corporation") under the laws of the State of Florida.

ARTICLE I

The name of the Corporation shall be:

Lance A. Ragland, P.A.

The Corporation's business shall be carried on at such places in the State of Florida, the United States or foreign countries as may, from time to time, be authorized by the Board of Directors.

ARTICLE II

The purpose for which the Corporation is organized is to engage in the Practice of Law.

ARTICLE III

The maximum number of shares of stock the Corporation is authorized to have outstanding at any time shall be Ten Thousand (10,000) shares of Common Stock. All the aforementioned stock is to be issued as fully paid and exempt from assessment. The capital stock may be paid for in money, property, labor or services, at a just valuation to be fixed by the incorporator or by the Directors at a meeting called for such purpose.

ARTICLE IV

The Corporation shall exist perpetually.

ARTICLE V

The principal place of business and mailing address of the Corporation shall be: 1009 E. Hwy. 436, Altamonte Springs, FL 32701, and may have such other places of business, both within and without the State of Florida and in foreign countries, as may be necessary and convenient.

ARTICLE VI

The business of the Corporation shall be conducted by a Board of not less than one (1) nor more than five (5) directors. The exact number of directors to be fixed by the Bylaws of the Corporation. Directors need not be stockholders.

ARTICLE VII

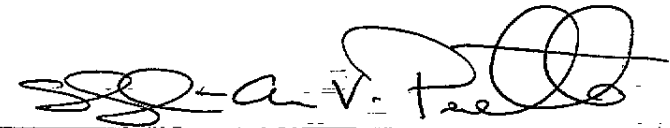

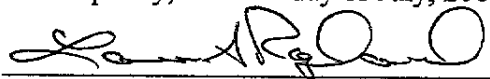
