ARTICLES OF INCORPORATION

The undersigned Subscriber to these Articles of Incorporation, a natural persons competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is

PC ENTERPRISES OF SOUTHWEST FLORIDA, INC.



ARTICLE II - DURATION

The existence of this corporation is to begin at the time of subscription and acknowledgment of incorporation and to continue perpetually thereafter.

ARTICLE III - PURPOSE

This corporation is organized for the primary purpose of owning, managing and operating a computer consulting, technical support and software design and implementation business.
